 - A discussion took place regarding the township's potential desire for the building.

 - 2 more scheduled this week.

- Mr. Foder We could be left with no representations for the elementary schools, we need to push this to the state level. Believes this is a very good thing to be done. Do they need to be registered voters?

Asked if the Board has heard from the commissioners since the last meeting. What happens if Regionalization comes along regarding Bass River seats on the new Regional K-12.
- Scott Ruch What I saw tonight was embarrassing. Urged the Board to have compassion and come together in these last two months to ensure they still have a say in the education of Bass River students. What happens if on May 3rd, the Board hasn't hired a new BA?
 - Mrs. Adams advised she would go to the County Office of Education at that point. In the event that a Little Egg Harbor seat would go to Bass River, how would that Board configuration work?
 - Mrs. Bitzberger Upset there will be no representation on the Little Egg Harbor school board. Urged for public support for the petition.
- Nick Capriglione Commission of Bass River Township; asked the Board if they have any questions for the Board.
 - Mr. Yates advised Mr. Capriglione that he is not here on official township business and Mr. Foder is not at a commissioners meeting as an official member of the Board.
- Mr. Capriglione inquired about asbestos in the building, oil tank in the ground, and any other concerns that the township or residents should be made aware of.
